- fully respect confidentiality requirements in dealing with child protection matters.

The school will also adhere to the above principles in relation to any adult pupil with a special vulnerability.

- In relation to the provision of information and, where necessary, instruction and training, to staff in respect of the identification of the occurrence of harm (as defined in the 2015 Act) the school-

  - > Ensures all new staff are provided with a copy of the school's Child Safeguarding Statement
  - > Encourages staff to avail of relevant training

#### Child Safeguarding Risk Assessment

In accordance with section 11 of the Children First Act 2015 and with the requirements of Chapter 8 of the Child Protection Procedures for Primary and Post Primary Schools (revised 2023), the following is the Written Risk Assessment of Adamstown Community College.

#### 1. List of school activities

- Recreation breaks for students are as follows: Monday to Thursday 10.39 to 10.54 and 12.50 to 13.25. Friday 11.29 to 11.59.
- Classroom teaching is conducted as per agreed maximum class sizes
- One-to-one or small group teaching is conducted for learning support and EAL.
- One-to-one and small group counselling as well as group bereavement takes place
- Outdoor teaching activities occur from time to time
- Most major sports activities are facilitated in school competitions
- School outings are facilitated for coursework and TY modules
- School trips involving overnight stays take place in TY and LCA
- School trips involving foreign travel. One foreign trip in junior cycle and one trip in senior cycle is facilitated. Some other trips take place for programmes and projects the school is involved in.
- Clearly marked toilet/changing/shower areas are provided within the main school building and the adjacent sports hall.
- An annual sports day takes place for 1- year students.
- Fundraising events involving pupils take place in TY.
- Use of off-site facilities for school activities is facilitated for some coursework activities and TY modules
- School transport arrangements always include use of bus escorts for supervision
- Care of children with special educational needs, including intimate care where needed.
- Administration of Medicine
- Administration of First Aid
- Curricular provision in respect of SPHE, RSE, Other wellbeing programmes
- Prevention and dealing with bullying amongst pupils
- Training of school personnel in child protection matters
- Use of external personnel to supplement curriculum.
- Use of external personnel to support sports and other extra-curricular activities
- Care of pupils with specific vulnerabilities/ needs such as
  - Pupils from ethnic minorities/migrants
  - Members of the Traveller community
  - Lesbian, gay, bisexual or transgender (LGBT) children
  - Pupils perceived to be LGBT
  - Pupils of minority religious faiths
  - Children in care
  - Children on CPNS

- Particular risk caused when supervising student bathrooms
- Risk of harm from Medicines or first aid procedures
- Communication of information regarding vulnerable students or students with medical or physiological/learning difficulties.
- · A child being harmed by bullying.
- Risk caused by the use of external staff
- Use of I.T equipment, computers, phones, social media or other devices while at school.
- Risk of harm related to online teaching and remote learning
- External persons facilitating curricular modules.
- Creating a safe environment for students with vulnerabilities, from ethnic groups or minority groups

- The school has yard/playground supervision procedures to ensure appropriate supervision of children during assembly, dismissal and breaks and in respect of specific areas such as toilets, changing rooms etc.
- The school has in place a policy and clear procedures in respect of school outings
- The school has a Health and Safety Statement (policy)
- The school and the educational training board adheres to the requirements of the Garda vetting legislation and relevant DES circulars in relation to recruitment and Garda vetting
- The school has a codes of conduct for school personnel (teaching and non-teaching staff)
- The school complies with the agreed disciplinary procedures for teaching staff
- The school has a Special Educational Needs policy
- The school has an intimate care policy/plan in respect of individuals students who require such care
- The school has in place a policy regarding the administration of medication to pupils
- The school
  - Has provided each member of school staff with a copy of the school's Child Safeguarding Statement
  - Ensures all new staff are provided with a copy of the school's Child Safeguarding Statement

- The school has in place a policy and procedures for the use of external sports coaches
- The school has in place a policy and clear procedures for one-to-one teaching activities

- The staff are adequately notified of the DLP and Deputy DLP in the school.
- The school requires adequate notification of absence to the Deputy Principal and substitution is put in place. Included in the daily timetable.
- All Garda clearance must be in place at time of recruitment but before commencement of employment.
- Building is monitored by senior management and caretaker. Defects are noted and actioned immediately or restrictions put in place if safety concerns arise. Building unit of ETB may be notified.
- Safety rules and training is provided to everyone using chemicals including use of safety equipment and procedures if accidents occur. First aid resources available in specialist rooms.
- Areas used for physical education and sports are monitored and assessed periodically and written reports are provided. Students are advised regarding proper clothing and footwear and made aware of any safety precautions involved in activity.
- Staff are responsible for reporting and safety concerns observed in addition to formal monitoring procedures.
- The school provides adequate supervision for student groups leaving the school for sport or other activities. Mobile phones are provided to staff and contact numbers are provided to students who are going on trips, overnight stays or foreign travel.

Important Note: It should be noted that risk in the context of this risk assessment is the risk of "harm" as defined in the Children First Act 2015 and not general health and safety risk. The definition of harm is set out in Chapter 4 of the Child Protection Procedures for Primary and Post-Primary Schools (revised 2023)

In undertaking this risk assessment, the board of management has endeavoured to identify as far as possible the risks of harm that are relevant to this school and to ensure that adequate procedures are in place to manage all risks identified. While it is not possible to foresee and remove all risk of harm, the school has in place the procedures listed in this risk assessment to manage and reduce risk to the greatest possible extent.

## Examples of activities, risks and procedures

The examples listed in this document are provided to assist schools in undertaking their risk assessment under the Children First Act, 2015. Schools should note that this list of examples is not intended to be exhaustive. It is the responsibility of each school to ensure, as far as

possible, that any other risks and procedures that are relevant to its own particular circumstances are identified and specified in the written risk assessment and that adequate procedures are in place to address all risks identified.

It is acknowledged that schools already have in place a range of policies, practices and procedures to mitigate the risk of harm to children while they are participating in the activities of the school and that some school activities will carry low or minimal risks of harm compared to others. In the context of the risk assessment that must be undertaken by schools, the Children First Act, 2015 refers to risk as "any potential for harm". Therefore, it is important that, as part of its risk assessment process, each school lists and reviews all of its various activities (which shall include identifying those that may carry low risk of harm as well as those that carry higher risks of harm). Doing so will help the school to (1) identify, as required under the Children First Act, 2015, any risks of harm that may exist in respect of the school's activities, (2) identify and assess the adequacy of the various procedures already in place to manage those risks of harm and (3) identify and put in place any such additional procedures as are considered necessary to manage any risk identified.

The Addendum to Children First: National Guidance for the Protection and Welfare of Children published in January 2019 clarifies that organisations providing relevant services to children should consider the specific issue of online safety when carrying out their risk assessment and preparing their Child Safeguarding Statement.

The Guidance on Continuity of Schooling for primary and post-primary schools (April 2020) advises of the importance of teachers maintaining the safe and ethical use of the internet during distance learning and assisting parents and guardians to be aware of their role also. Schools should ensure that their Acceptable Use Policy (AUP) informs and guides remote or distance learning activity.

Important Note: It should be noted that risk in the context of this risk assessment is the risk of "harm" as defined in the Children First Act, 2015 and not general health and safety risk. The definition of harm is set out in chapter 4 of the Child Protection Procedures for Primary and Post Primary Schools (revised 2023).

#### Examples of Risks of Harm

- Risk of harm not being recognised by school personnel
- Risk of harm not being reported properly and promptly by school personnel

- Risk of child being harmed in the school by volunteer or visitor to the school
- Risk of child being harmed by a member of school personnel, a member of staff of another organisation or other person while child participating in out of school activities e.g. school trip, swimming lessons
- Risk of harm due to inappropriate use of online remote teaching and learning communication platform such as an uninvited person accessing the lesson link, students being left unsupervised for long periods of time in breakout rooms
- Risk of harm due to bullying of child
- Risk of harm due to racism
- Risk of harm due to inadequate supervision of children in school
- Risk of harm due to inadequate supervision of children while attending out of school activities
- Risk of harm due to inappropriate relationship/communications between child and another child or adult
- Risk of harm due to children inappropriately accessing/using computers, social media, phones and other devices while at school
- Risk of harm to children with SEN who have particular vulnerabilities, including medical vulnerabilities
- Risk of harm to child while a child is receiving intimate care
- Risk of harm due to inadequate code of behaviour
- Risk of harm in one-to-one teaching, counselling, coaching situation
- Risk of harm caused by member of school personnel communicating with pupils in an inappropriate manner via social media, texting, digital device or other manner
- Risk of harm caused by member of school personnel accessing/circulating inappropriate material via social media, texting, digital device or other manner
